**Holt County receives "good" rating from Missouri State Auditor**

*Auditors recommend some improvements to be made*

Missouri State Auditor Nicole Galloway has released an audit of the government of Holt County. The audit received a performance rating of "good", which means that the county is well managed. The report contains few findings, and the entity has indicated most or all recommendations have already been, or will be, implemented. In addition, if applicable, many of the prior recommendations have been implemented. There were, however, some areas of concern identified.

Auditors recommended improvements to accounting procedures in the sheriff's office, including procedures related to the operation of a commissary where inmates can purchase snacks and personal items. The sheriff's office contracts with a vendor to provide the commissary. The sheriff also handles money received for concealed carry weapon permits, bonds posted for bail, and other various items.

The sheriff has not adequately segregated the duties related to

handling money for the commissary account, and no supervisory review of accounting records is performed, putting the county at risk for potential mismanagement. A running balance is not maintained in the checkbook register for the fee account, which means bank balances can't be rec-

## Remembering

"Why did we let it happen?" In the paper the other morning, one of the cartoons that I don't usually read caught my eye. It was a mom with her kids in the "Family Circus", to refresh your memory if you didn't read it. The little girl asked her mother, "Mommy, how do we tell the difference between a hello wave and a goodbye wave?" That question fits us now, in just about everything we see on TV or read in the newspapers. Are people telling the truth today or not telling the truth? Tomorrow it may change again, to fit with what they want us to know. When you stop and think about going in the political arena, it could be labeled the "Country Circus" instead of the "Family Circus" and printed up in the comic section of the newspapers. Most of the time they are funnier than the comics, in my opinion anyway.

Back before WWII, with the exception of a few, this country was being run, enjoyed and conducted, like our forefathers expected it to be. A few years after WWII, during the return to peace time, a lot of fortunes were made through the Black Market deals, both by civilians and the military. This was not right, but if you needed something you followed along. Remember that the entire USA had been on rationing and didn't mind buy-

ing that way, if people had the money. We bought a car and several farming equipment pieces ourselves. The Black Market in the military was more popular in Europe, rather than the Pacific, due to not only more military there, but more access to materials that would sell. The practice, if you want to call it that, followed and grew in Washington, D.C., where our elected officials continued the old Black Market in a more official program called Congress, allowing greed to eventually govern the outcomes. After a few years, they struggled for power to maintain their existence and stay in DC. The combination of greed and power was thought to be bad, until the movement to control took over.

Up until after WWII, no one thought a whole nation could be under government control at the same time. With all the legal immigrants who had escaped their home countries to get out from under full control, over 16 million veterans, who were tired of two wars at once, mandated defense work; and in some cases, rationing of most everything. Instead of being plain Americans, we were gradually being separated into groups where control is easier and faster than control of individuals. The old saying "United We Stand and Divided We Fall" was completely turned around. I

made a remark that now, due to segregation and that's what it is, we could go to any town or city and take a poll and at least 50% wouldn't care what happened because of their complacency just so they weren't affected. Surprised?

Our family lives have changed more than ever, especially between generations for the first time. I don't know what all Betty and my families are doing or their everyday whereabouts. We used to catch up weekly on events happening in our lives. It isn't because we don't have the best communication, it's just not the same old feeling. The expense of growing old and burial has risen to be more everyday, mostly due to these regulations to take the best care of us. Their eyes are on your securities and holdings that you worked hard to save for retirement. The committee set up to protect us from ourselves must have some pages missing. The practice of using borrowed money and increased taxes has gotten our country on a one way street, but maybe a miracle will happen and for Christmas, China and others we owe, will give us a gift and void all the debts. I'm glad I can still remember the good old days, how about you? There is an old Army saying, "watch your back". Take care.

## MDC expands pheasant hunting to statewide

The Missouri Department of Conservation (MDC) reminds hunters that pheasant hunting has been expanded in Missouri from only the northern half of the state and a portion of the southeast to statewide starting with this year's fall hunting season.

Pheasant hunting starts with a youth-only weekend on Saturday and Sunday, Oct. 24-25, followed by the regular season of Nov. 1 through Jan. 15, 2016. Hunting remains limited to male pheasants only. The daily bag limit is two male birds and the possession limit is four. Valid permits are Daily Small Game Hunting, Small Game Hunting and Fishing or Small Game

Hunting. Pheasant hunting in Missouri was previously limited to a North Zone consisting of all counties north of Interstate 70 and a portion of St. Charles County south of I-70, and a Southeast Zone consisting of Dunklin, New Madrid, Pemiscot, and Stoddard counties.

According to MDC Resource Scientist Beth Emmerich, the expansion of pheasant hunting to statewide will simplify harvest rules for hunters across the state with minimal impact to the overall pheasant population.

"Hens are protected from harvest and one rooster often mates with multiple hens. Our rooster-only hunting season has very little impact on overall population

size and growth," Emmerich said. "Habitat is what's key for developing and maintaining wildlife numbers, including game birds such as pheasants and quail. Pheasant populations improve with ample nesting and brood-rearing habitat, including open grassy and agricultural fields."

Emmerich noted that not all areas of the state have pheasants. "There is noticeable variation in pheasant populations around the state with northwest Missouri and portions of the northeast holding the most birds," said Emmerich. "Many parts of the state do not have the type of habitat required to hold pheasants. Expansion of pheasant hunting to statewide does not imply that birds can be harvested or even observed in all areas of the state."

Emmerich added that other game species also have statewide hunting seasons regardless of not hav-

ing significant populations in all parts of the state, including quail, swamp rabbit and woodcock."

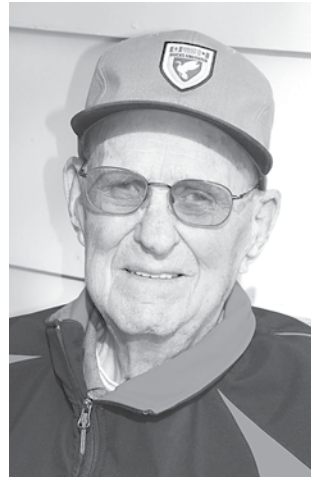

## Pesticide applicator changes proposed by EPA

The Environmental Protection Agency (EPA) is accepting comments on proposed changes to the federal EPA Certification of Pesticide Applicators' Rule. These changes are found in the Federal Register, Volume 80, No. 163, on Monday, August 24, 2015. Since these regulations are very important to the farming community, interested parties should comment on the regulation. The public comment period runs through Monday, November 23, 2015.

EPA is proposing stricter standards for people certified to use restricted use pesticides and to require all people who apply restricted pesticides to be at least 18 years old. Certifications would be renewed every three years. Additional specialized licensing is proposed for certain methods of application such as fumigation

and aerial application. Individuals working under the supervision of certified applicators would now need training on using pesticides safely.

EPA is also proposing a Continuing Education Credit (CEU) Training Program. CEUs are defined as 50 minutes of active training time. This would mean both private and commercial applicators would need to receive six CEUs covering general standards as application techniques, three CEUs for each private category such as aerial, soil fumigation and non-soil fumigation and six CEUs for each commercial category.

# Holt County receives "good" rating from state auditor

*Auditors recommend some improvements to be made*

onciled against the checkbook register. Monthly lists of amounts owed are also not prepared, so there is less assurance that available cash is sufficient to pay all liabilities.

The state auditor recommends that the Holt County Sheriff adequately segregate accounting duties or ensure an independent or supervisory review of accounting and bank records is performed and documented; and maintain a running balance in the checkbook register and reconcile the bank balance to the book balance monthly. In addition, ensure that a list of liabilities is prepared and reconciled to the cash balance monthly. Any differences should be promptly investigated. After sufficient efforts are made to resolve differences, any remaining unidentified monies should be disposed of in accordance with state law.

According to Holt County's response to the state auditor, the above recommendation has been implemented. A running balance is now maintained and is reconciled to the bank account monthly. The sheriff's office is now preparing lists of liabilities monthly and the difference identified during the audit has been investigated and distributed to the Holt County Treasurer.

The report also identified threats to the security of information in some county offices related to password and computer controls. Employees in multiple county offices, including offices of the county collector, prosecuting attorney, recorder of deeds and county assessor, are not required to periodically change their passwords, putting accounts at risk for unauthorized access.

The Missouri State Auditor recommends that the Holt County Commission work with county officials to require employees periodically change their passwords to prevent unauthorized access to the county's computers and data.

According to Holt County's response to the state auditor concerning the above recommendation, Holt County will work with its elected officials and network providers to strengthen controls over passwords.

Because counties are managed by several separately-elected individuals, an audit finding made with respect to one office does not necessarily apply to the operations in another office. The overall rating assigned to the county is intended to reflect the performance of the county as a whole. It does not indicate the performance of any one elected official or county office.

The Missouri State Auditor's office audited certain operations of Holt County in accordance

with the standards applicable to performance audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. In addition, McBride, Lock & Associates, LLC, Certified Public Accountants, was engaged to audit the financial statements of Holt County for the two years ending December 31, 2014. The scope of the audit included, but was not necessarily limited to, the

year ending December 31, 2014. The objectives of the audits were to:

1. Evaluate the county's internal controls over significant management and financial functions.
2. Evaluate the county's compliance with certain legal provisions.
3. Evaluate the economy and efficiency of certain management practices and operations, including certain financial transactions.



## Fire hydrant malfunction causes water outage

**Residents in the north end of Mound City** - Found themselves without water on Monday morning, October 26. Repairs were being made on a fire hydrant at Griffith Park when pieces of the hydrant broke, sending water spewing. The fountain of water quickly covered the surrounding area before the city water department could get the water shut off. According to Mayor Chris Krueger, water was turned back on by late afternoon on Monday, after the replacement of the fire hydrant. Residents of Northridge Apartments and homes on Weightman Road and Sunset Boulevard were under a boil advisory for 72 hours.

At the time of the disastrous museum fire in 1994, many school items, maps, books and documents were in the little 1907 school building and were not destroyed.

A *Holt County Sentinel* news item January 1, 1869, shares that the county superintendent was setting dates to visit the county's country schools in Holt County. There were 24 listed and the county was then only 28 years old!

### KELSO SCHOOL

While researching country schools, it was found that the first Kelso Country School was a brick building. An undated photo labeled "Kelso?" was sent some time ago to the Holt County Historical Society by Mary Virginia Lawrence Nevin of Downey, CA. It was thought the identification was incorrect as everyone recalled it being a two-story frame building that was eventually acquired by Clyde Miller and moved to Big Lake.

Kelso School was a brick building at one time. *Craig Leader* April 22, 1887, shared that a new brick building

# Centenarian receives accolades from Missouri House of Representatives

Inez VanOrman of Mound City greeted over 120 family members and friends at her 100th birthday party at the Mound City Nutrition Site on Sunday, October 25. Inez's great-grandchildren served cake, cookies and punch to the well-wishers that filed in to celebrate with Inez. Her three children, Nana Ruth Mulvania, John E. "Sonny" VanOrman, Jr., and Jane Ann Egbert organized the event.

Gifts and cards were abundant, but seeing her family, friends and church family were the best part of the whole day, according to Inez. District 1 Missouri State Representative Allen Andrews arrived at the party with a proclamation from the Missouri House of Representatives. Earlier in the week, Inez received three letters of congratulations from Washington, D.C.

On Monday, October 26, Inez, worn out but still sporting her beautiful smile, sat down to reminisce about her life. At 100 years old, she has a great memory and

fantastic stories to tell.

Inez and her late husband, John, grew up in Poplar Bluff, MO, dating in high school. She recalls how John was a track star, later making it into the Poplar Bluff Hall of Fame for the many track accomplishments he had, including several broken records. During this time, 16 year-old Inez lost her mother from complications during childbirth, leaving Inez to care for a newborn sister, a six year-old sister and a 14 year-old brother with the help of her older brother, Dalton, who was 18 months older than Inez. Their father worked on the railroad and was gone from home quite often. Inez states her brother, Dalton, was the rock of the family of siblings, and the two of them kept the household going when their father was out of town.

During the 1920's and 1930's, times were very hard because of the Great Depression. Food was rationed and many people lost their jobs. Inez's family was fortunate that her father worked for

Missouri/Pacific Railroad. Even though her father would sometimes get laid off, the railroad always made sure the workers had enough rations to feed their families.

Soon after high school, Inez and John married, making their home in Poplar Bluff. John was gaining a reputation as a good mechanic and soon word reached clear up to Mound City that "John VanOrman was the man to fix your truck." In the early 1950's, Paul Booker, Jr., the owner of International Harvester in Mound City, persuaded John to move his family to Mound City and be the manager of the shop at International Harvester. Several years later, John went to work for Crouse Brothers Motors in Mound City as a mechanic, soon to be moved to the parts department. John worked at Crouse Brothers for 30 years before retiring. After a debilitating stroke in 1993, John passed away in 1996.

During the early years of their marriage, Inez was a stay-at-

home mother with her three children. After the youngest, Jane Ann, started school, Inez worked at Mound City Flowers for Ruth Martin and Eva Browning. As with most florists, holidays and many weekends were workdays and Inez felt she was missing out on family time. After two years, Inez went to work at the Mound City school, working part-time in the cafeteria until 1962, when Inez decided to go back to being a stay-at-home mother and wife. Family has always been her love and joy.

When Inez and John moved to Mound City, they were looking for a Baptist church. They had been raised as Baptists in Poplar Bluff. There was not a Baptist Church in Mound City at that time, so the VanOrman family visited several of the local churches. An invitation came from the New Liberty Baptist Church, several miles north of Mound City. John and Inez took their family to the "little country church" and Inez is still a member of New Liberty.

The New Liberty church family means the world to Inez.

Inez's face lights up when talking about her grandchildren and great-grandchildren. She has nine grandchildren and 19 great-grandchildren. One granddaughter is deceased. From being the nurturing big sister to raising

# Nodaway-Holt Board of Education discusses Dual Credit option

The Nodaway-Holt R-VII Board of Education met in regular session on Tuesday, October 20, at the school in Graham, MO. Members present were: Joe Day, Kenny Shewey, Scott Clement, Bob Saxton, Mike Rosenbohm and Jim Fuhrman. Jane Hanson was absent. Others in attendance were Superintendent Karma Coleman, Principal Ethan Sickels, Principal Rita Carroll and Secretary Beverly Shifflett. Dustin Henggeler from the *Nodaway News Leader* was present as well as teachers, Jaymee Koop and Megan Frueh.

President Saxton called the meeting to order at 7:14 p.m. Minutes from the September 16 regular session and the September 16 executive session were approved. The financial statement and the student activities' report were discussed. Jaymee Koop and Megan Frueh spoke to the board members about the things they are doing in their classrooms.

Elementary Principal Rita Carroll presented her report. The current enrollment in the elementary school is 118 with the breakdown as follows: Kindergarten - 10; First Grade - 20; Second Grade - 14; Third Grade - 13; Fourth Grade - 16; Fifth Grade - 21; and Sixth Grade - 24. New students to the district include: Zaryn Martin from Rock Port, MO, in First Grade; Mason Miller from Rock Port in Third Grade; Journee Parman and Tyller Parman, both from a home school program in Fifth Grade; and Trenton Martin in Sixth Grade. Students leaving the district include: Hailey Lukehart in Kindergarten to St. Joseph, MO; Payton Morrison in First Grade; Keara Erb in Second Grade to Poplar Bluff, MO; Tessa Lukehart in Second Grade to St. Joseph; Tara Erb in Third Grade to Poplar Bluff; Malaki Parkhurst in Third Grade to Bethany, MO; and Marrie Erb in Fourth Grade to Poplar Bluff. Attendance in the elementary school was 95.9% for the first quarter.

Principal Carroll presented the Missouri Assessment Program

(MAP) results for third, fourth, fifth and sixth graders showing percentages in proficiency for the years of 2012, 2013, 2014 and 2015.

The first graders have made two visits to the Nodaway Nursing Home to sing for the residents and share books. The junior high volleyball girls accompanied them on the first trip and the high school football players went on the second trip. Several of the residents have family ties to the school district's area and all residents enjoy the visits. Apple Bus Company provided transportation for this service project.

Twenty families attended the Title I Family Reading and Math Night. Families learned how to navigate the website that provides support for the new math series. The library web page was shared with families so that they can enjoy the free e-books that are available.

Fourth graders attended the Conservation Kids' Day at Nodaway Lake, however it rained and a soaked group of students and their teacher returned to school before lunch that day. While disappointed that rain prevented the event from being rescheduled, the group did have a visit from the area Bee Queen to share information with students about the importance of bees.

Students attending the October Mark Twain Club meeting were treated to a visit from the Nodaway County Humane Society and a special service dog. Students brought items to donate for use in animal care.

The Skidmore, MO, and Maitland, MO, fire departments brought fire trucks and equipment for students to learn about during Fire Prevention Week. A fire drill made the day complete.

Fifth and sixth graders attended the Holt County Career Fair in Oregon, MO. Students listened to 13 speakers from various career paths.

Saturday, November 7, will host the seventh annual Trivia Night sponsored by the elementary school staff to help raise money for the elementary building in Maitland.

Other calendared events include: October 30 - Halloween Hot Dog Roast, Parade of Costumes and Parties; November 2 - No School due to Teacher In-Service; November 3 - Character Assembly; November 4 - Lions Club Hearing Screening (Kindergarten through Third Grade); November 5 - First Grade will sing the National Anthem at the Junior High Basketball Game; November 9 - Literacy Night (Primary Grades); and November 11 - Mark Twain Club.

High School Principal Ethan Sickels presented his junior high senior report. Total enrollment is at 107 students with the breakdown as follows: Seventh Grade - 13; Eighth Grade - 21; Freshmen - 15; Sophomores - 16; Juniors - 21; and Seniors - 21. Attendance for the first quarter was 97.08%. New students to the district include Miranda Partridge, a junior, from Maryville, MO; Gracie Szesny, freshman, from Rock Port; and two returning students, Alexis Chrisman, eighth grader from Maryville, and Sam Keith, junior from Maryville. Two students have moved from the district. They are Kristen Keith, senior, to Maryville, and Tommy Wilmes, sophomore, to a home school program.

Principal Sickels presented the MAP results for seventh and eighth graders as well as end-of-course results in Algebra I, English II, Biology and Government. These results showed the years of 2012, 2013, 2014 and 2015.

The first cooperative homecoming with South Holt went pretty well. Activities during the week were held at Nodaway-Holt and then students traveled to Oregon, MO, for the Pep Rally on the square on Friday of homecoming week. The students went all out for the dress-up days and Mrs. Madden did a good job in organizing the activities according to Mr. Sickels. Next year's homecoming will be held from September 19 to 23 with the football game against Stewartsville, MO, to be played at Graham.

Northwest Missouri State University (NWMSU) in Maryville is making a big push to be the sole provider of Dual Credit courses in the northwest Missouri area. NWMSU officials are hoping to offer it in more of a variety (online, video conference, taped lectures) and are considering a proposal that if Nodaway-Holt uses only NWMSU, then the university will offer either money towards credits for the future students or a rebate of some sort back to the school or students. A lot of discussion will be necessary before a decision is made to go with NWMSU only for Dual Credit courses.

Fairfax, MO, and Tarkio, MO, have officially announced that they will join together in all sports at all levels beginning next year as East Atchison. It will not cause too many changes in scheduling with all the schools just taking an open night where Fairfax was on the schedule, but it will cause the school district to lose one or two games a year depending on the sport.

Volleyball districts and football districts are underway. (Nodaway-

Holt placed second in district volleyball; and Nodaway-Holt's football team is set to play North Andrew at Rosendale, MO, on Friday, October 30, at 7 p.m. in district football after a win over Stewartsville at Graham on Friday, October 23.)

There are 13 girls and six boys out for junior high basketball this year. The first game was scheduled for Monday, October 26, at Northeast Nodaway in Ravenwood, MO. High school basketball begins on Monday, November 2.

The calendar of events follows: October 28-31 - FFA National Convention; October 31 - Band at Peru, NE, State Homecoming Parade; November 2 - No school due to Teacher In-Service; November 3 - Vision Screening Day; November 4 and 7 - Nodaway-Holt Junior High Basketball Tournament; November 9 - FFA Trapsheet at Smithville, MO; November 11 - Veterans' Day Assembly; and November 20-22 - School Play, "Larceny and Old Lace".

Superintendent Karma Coleman gave her report. Mike Rosenbohm presented a Missouri School Boards' Association (MSBA) report. Monday, October 26, was the MSBA Region I Fall Meeting at North Nodaway in Hopkins, MO.

The Title I Program, Homeless, ELL, and Migrant Program Evaluations were approved by the board. Board policy revisions were also approved. Three board policies were rescinded and the first reading of the Board of Education Policy DLCA was accepted.

The board went into executive session at 8:12 p.m. to discuss personnel, as per section 610.021 RSMo, closed record and closed vote as per section 610.022 RSMo. The meeting was adjourned at 9:53 p.m.

# Red Rock landmarks in Mound City...THEN and NOW

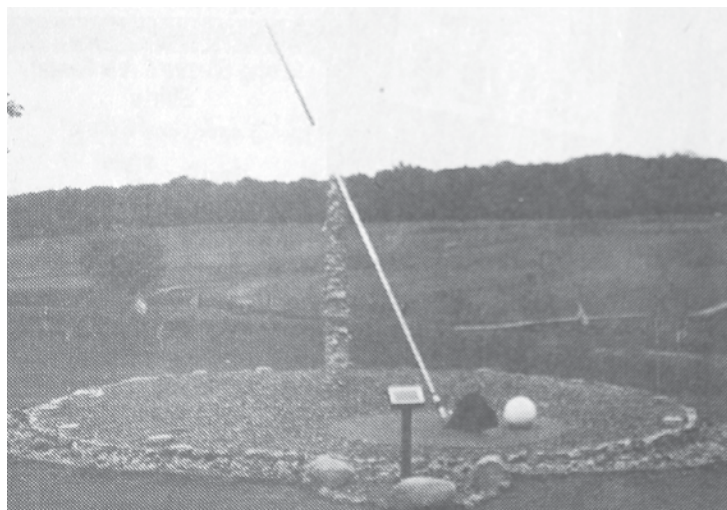
Twenty-five years ago, the *Mound City News* ran a full page devoted to the various red rock structures that were seen in Mound City in the fall of 1990. As reported in the October 25, 1990, paper, "It's a nice way to entertain out-of-town guests while giving them a tour of the city."

*Midwest Living* magazine had recognized the red rock project as an honor roll selection in a feature on hometown pride projects. Melinda Tally, a member of Ta Ya Mim, a women's organization in charge of Mound City's "Adopt-A-Rock" program, coordinated the submission of the entry to the magazine.

Dr. J. Bruce McRae is quoted with background information on the selected red rock structures that were featured in the week's paper. McRae was instrumental in the construction of the red rock structures with the hopes of creating a self-guided Volkswalk tour through Mound City, promoting the town, fitness and the prolific amount of red rocks in the area.

In 2015, the *Mound City News* is reviving the article from 1990 and adding current information about the red rock structures featured in 1990. Some of the updates are happy, improved stories and, unfortunately, some of the updates reflect deterioration or demise. The community is in need of a "Dr. McRae" to continue this legacy.

## "World's Largest Sundial"

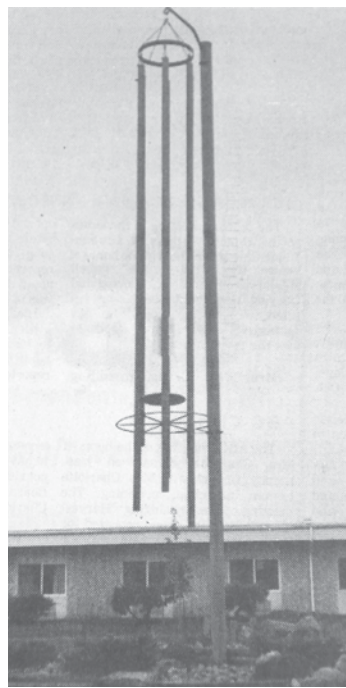


**THEN:** "Lois Drewes got the idea for the sundial when she saw the world's biggest sundial in Arizona, where they winter. The idea of putting the golf club on it was Gene Ceglenski's. He saw one in Vancouver with a huge hockey stick on it and a giant hockey puck and he said, "Why don't we put up a golf club and a golf ball?" So we did." It was completed this summer (1990) at the golf course.



**NOW:** Time had taken a toll on the sundial structure, but the Mound City Golf Association solicited contributions (monetary, materials and labor) to rehabilitate one of the favorite structures in town. Mound City Golf Association board member, Roger Faber, took the project under his wing and created a sundial that has been calibrated to be accurate at each of the four solstices during the year. Faber positioned the sundial elements to be exclusive to its location by moving the angle of the golf club to make it parallel to the earth's axis (40.13 degrees) at a true north angle. The flags at each number position have been placed askew by 5 degrees to adjust for Mound City's position in the central standard time zone. The base of the sundial has been rebuilt with the original red rocks slated to form a border inside the sundial. At this time, gravel will complete the surface of the face of the sundial with synthetic turf planned in the future. Plaques will adorn the front of the sundial with the history of the structure and an explanation of how the sundial works. Thanks to hard work, the sundial is once again a Mound City landmark.

## Wind chimes at Tiffany Heights

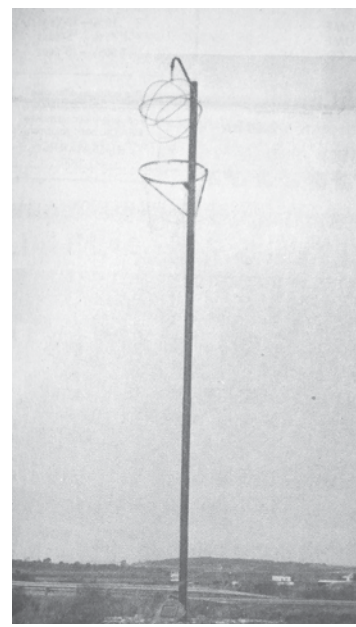


**THEN:** "Lots of towns have tourist attractions that are 'The world's biggest,' whether it's the biggest bull or the biggest goose on the biggest something. The Knights of the Round Table were talking about what we could have that would be the biggest and Alex Horvath came up with the world's biggest wind chimes. This was the first red rock project. We built it in 1987." It's outside Tiffany Heights on Nebraska Street.



**NOW:** Over the years, the wires holding each of the massive chimes weakened and dropped the chimes. Today the chimes are being stored in the hopes that they can be replaced and the pole holding the chimes can be repaired. The wind chimes make another of Dr. McRae's creations that is in need of repair.

## 1981 State Basketball Champions



**THEN:** "We had promised the boys who won the championship game that we'd do something for them. That was the Class of '81. It only took us eight years. We put it up in the summer of 1989, when Hardee's opened." Honoring the 1981 boys' team that won the state basketball championship, this one is in Hardee's parking lot, where the trail starts.



**NOW:** The parking lot the basketball structure sits in is now part of McDonald's instead of Hardee's. The appearance has remained the same over the course of the last 25 years. Many travelers up and down Interstate 29 have found the monument to be an interesting conversation piece over the years.

## Queen's Fountain in Griffith Park



**THEN:** "We built this one to honor the Miss Mound City. The crown represents the queen. They're crowned on the 4th of July, so we put the eagle on top. The Kiwanis Club provided the financing and we did it in 1988. 1988 was a good year." It's in Griffith Park.



**NOW:** The structure as seen today is even more attractive with the landscaping that surrounds it. It no longer has a fountain, but the intent of honoring Miss Mound City has been kept with the structure of the crown remaining atop the rock pillars. Community volunteers, Wava Duncan and Barb Heitman, plant and maintain the flowers surrounding the crown with supplies provided by the Mound City Kiwanis Club each year.

## Red Rock waterwheel



**THEN:** "There's a waterwheel down in St. Joe, you know, and when my wife saw it, she decided we ought to have a waterwheel in Mound City. That's how we got the idea for that one." The latest addition to the trail, it was erected outside the Pump and Snack on State Street, where the trail starts.



**NOW:** After replacing the pump of the waterwheel several times over the years, the structure was taken apart and abandoned. The Red Rock wall still stands, as does the structure the waterwheel sat on.

## Carillon Chimes at Concordia Lutheran Church



**NOW:** Over the years, weather has been cruel to the Carillon tower standing outside the (now) Holy Trinity Lutheran Church. Bells are missing and the structure is in need of paint; however, that is not the tower's main problem. The sound system located inside the church is not functioning. After several attempts to revive the system, the church has resigned to the fact that the sound system will have to be replaced with an expensive unit. The Holy Trinity Lutheran Church recognizes the great asset the Carillon tower is to the community, just as Welton and Delores Ideker were, who are memorialized on the base of the tower. The church hopes to refurbish the Carillon system in the future.

**THEN:** "I think Welton Ideker would have appreciated this one. He was a very frugal man. All of the materials came from his construction company . . . it was built, constructed and erected by Welton's own workers. Cast bronze bells were over \$300 each but I finally found the hard plastic ones we used and the fellow asked me if \$2 each would be all right. The clangers are toilet floats. I told the church I could get the sound system for the chimes for \$1,800 but when I finally found the music, the machine to play it cost \$4,200. I had to go back to the congregation. Morris Heitman quoted Luke 14, verse 28. The verse: "For which of you, intending to build a tower, sitteth not down first, and counteth the cost, whether he have sufficient to finish it?"

## Ways to make Halloween healthy and still fun

It won't be long before pint-sized Princess Elsas, Star Wars characters and Minions run through neighborhoods threatening tricks and demanding treats. Halloween doesn't have to be a complete sugar-overload holiday. There are simple things that parents can do to keep it fun and healthy.

First, don't send the little ones out on an empty stomach, says Tammy Roberts, nutrition specialist for University of Missouri Extension. "If children have a full belly before they go trick-or-treating, they're not as tempted by their candy," she says. Make the meal fun and festive, Roberts says. Spread cheese on whole-grain bread and let the children create faces using fresh vegetables. Then toast them under the

broiler.

After children return home after their romp is a perfect time to teach them about moderation. "Let them know that candy is OK, but not something we should have every day, and not something we should have a lot of when we have it," Roberts says. "Have your children choose one or two pieces of candy to enjoy and then save the rest for later."

One thing you should never do is forbid children from having any candy. "Whenever you think that you can't have something, that's when you will really, really want it," Roberts adds. "If the children know that it's OK to eat the trick-or-treat candy, having candy in moderation will be much more manageable for the

kids and parents."

Still, many parents don't feel comfortable handing out empty-calorie treats. There are great alternatives, Roberts says. Things like rings, bracelets, stickers, puzzles and bouncy balls are fun too.

There is one very important job at the end of the Halloween festivities. Remember that candy has a lot of sugar, which isn't good for teeth, Roberts says, so make sure Halloween revelers give teeth a good brushing before heading to bed.

## Have a safe Halloween

Colonel J. Bret Johnson, superintendent of the Missouri State Highway Patrol, encourages everyone to include safety in their plans for Halloween.

**MOTORISTS:** Young children excited by Halloween could dart in front of a vehicle. Slow down, and drive with extra caution. If you are

headed to a costume party, make sure the costume doesn't hamper vision while driving to the event. Motorists picking up and dropping off trick-or-treaters may increase the number of vehicles on the road, therefore affecting traffic patterns. Please be courteous and stay alert for trick-or-treaters of all ages.

**PARENTS:** Tell children to approach only familiar houses that are well lit. Remind children they should never enter a stranger's house or vehicle. Consider trick-or-treating with children for their safety and because it's a fun way to spend an evening.

**TRICK-OR-TREATERS:** Keep costumes short to prevent tripping and consider make-up rather than masks. Masks can make it difficult to see oncoming traffic. Wear light-colored clothing or add reflective tape to dark costumes to make them visible. Flame resistant costumes are the best ones. Remember to look both ways when crossing the street. Use sidewalks wherever possible when walking around a neighborhood.

Trick-or-treaters are urged to do so while it is light outside. Increase visibility by taking a flashlight along, especially after dark. An adult should always accompany small children, and older children should stay in groups.

**ADULTS:** Consider spending Halloween at home answering the front door. If attending a Halloween party that includes alcohol, make sure to have a sober, designated driver for the trip home. Alcohol, even in small amounts, slows reaction time and dulls the senses. Drinking alcohol could have a sad and possibly deadly result.

## The Big Picture of Locally Grown

It's a late crop this year, and farmers are finally busy harvesting corn and soybeans. The roads will be filled with farm trucks carrying grain from fields to grain bins. Some grain will be shipped out and fed to livestock. Some will end up at food processing plants; and some will be turned into fuel. Whether that happens in the United States or overseas all depends on who buys the commodities on the open market.

That brings me to a column I recently read from a blogger in Kansas. This farm wife wrote about when people find out they farm, they lend their support with an enthusiastic, "Oh, I always try to buy local." Thing is, their farm doesn't sell local, nor do they shop very often at the local farmers' market. Their corn and soybeans are delivered to the grain elevator, their cattle shipped to the livestock auction, and their groceries come from the store.

Our neighbors in Kansas are like most farmers in that the commodities they raise go many miles before ending up in consumers' hands. Sometimes the end result is found in the package of cookies at the grocery store or in the Big Mac and fries at the local McDonald's, and in that regard, farmers and ranchers buy and eat the same food we all enjoy.

There is another similarity. These families are not huge corporations, but everyday people who support their communities, schools and churches. Even though the soybeans they raise may end up in Japan, the income generated from the sale of those beans supports local and state taxes. The local volunteer fire

department would have a tough time protecting your home without the support of farmers. If you live in a small town, several of the volunteer firefighters are likely farmers. They are in my hometown.

The United States is the world's leading exporter of agricultural products, according to the International Trade Administration. At \$141.3 billion, agricultural exports made up 10 percent of U.S. exports in 2012. That number grew to \$152.5 billion last year. Since 1960, the U.S. has posted a trade surplus in agriculture. For Missouri, soybeans generate, by far, more export revenue than any other

agricultural commodity - to the tune of \$1.3 billion in 2013; and in 2014, many of those bushels, \$611,000 worth, were bound for the fourth largest buyer of Missouri soybeans - Japan. Missouri has become a premier state in soybean research because of it.

Farming is interwoven locally and overseas. According to a U.S. Department of Agriculture model, each \$1 billion of agricultural exports supported 6,800 American jobs in 2011. That is a huge economic driving force scattered in large and small communities across the U.S.

When you read those numbers, it gives "locally grown" a whole new meaning.

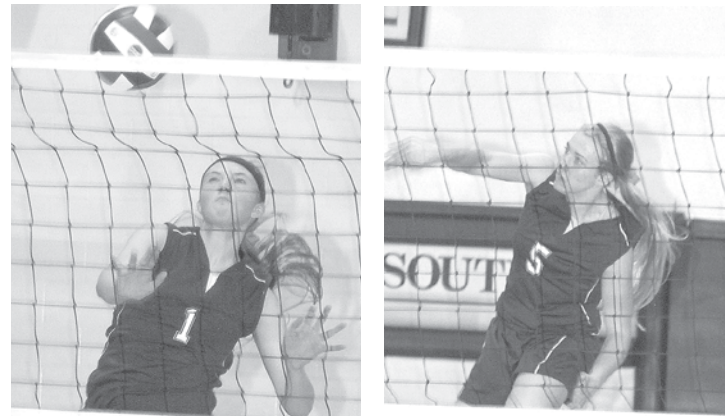
# Mound City Lady Panthers Class 1, District 16 volleyball champions

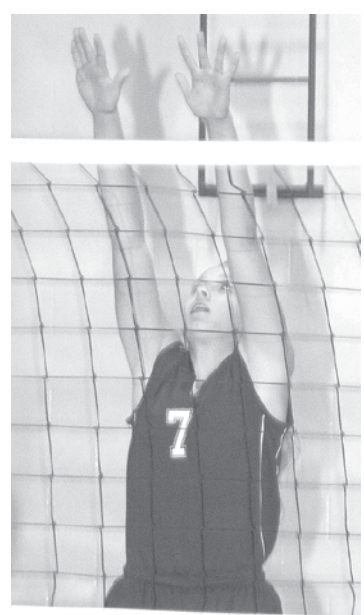

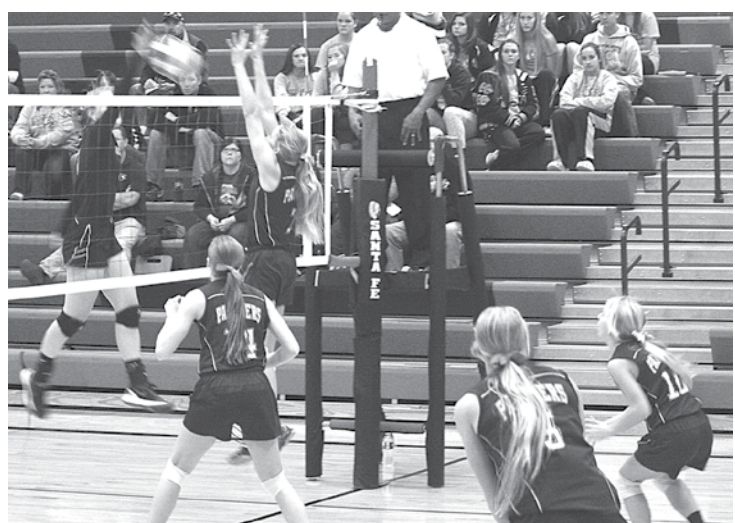

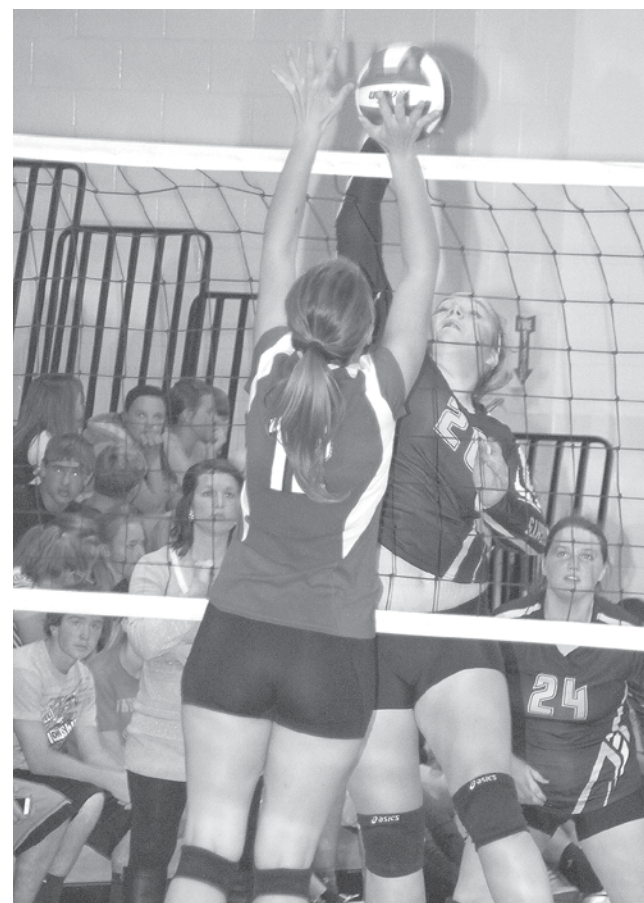
