AMBER Alert: Knowledge is power, safety is key

In the wake of recent child abductions in Missouri, parents and children should take the opportunity to review safety strategies in order to prevent another tragedy, like that of Hailey Owens, from happening. (Owens, 10, of Springfield, MO, was allegedly kidnapped by Craig Michael Wood, a middle school football coach, on Tuesday, Feb. 18. Owens was walking home from a friend’s house, according to a Fox News report, when Wood pulled her into his gold 2008 Ford Ranger. Although police were able to detain Wood within three

hours, it was too late for Owens, whose body was found in Wood’s basement. Wood has been charged with first-degree murder, armed criminal action and child kidnapping, according to *The Kansas City Star*.)

Safety starts at school and home, the two places where children feel most comfortable. Beth Graves, guidance counselor at Mound City R-2, for example, annually reviews safety strategies with her students. The system she prefers, “The Safe Side,” was designed by John Walsh of “America’s Most Wanted” fame

(Walsh’s son, Adam, was kidnapped and murdered in 1981; his death helped spur the government to create the National Center for Missing and Exploited Children). The Safe Side advocates not for “stranger danger” but for the varying relationships a child might have with an adult.

“There are three levels,” Graves said. “Someone you know, ‘kinda’ know and don’t know.”

According to the Safe Side, the terms “don’t know” and “kinda know” are more age-appropriate and precise. Children should be particularly cautious around those

they “don’t know” and should try to stay around “safe side adults,” or those they do know, at all times. Graves also encourages students to follow the Safe Side motto: smart, cool, safe.

“We tell kids there are times when it’s important to be smart (recognize danger), and other times when it’s important to be cool (be cautious and think),” Safe Side writes on its website.

“Staying safe is the reward for knowing what to do and doing it.”

Holt County Sheriff Scott Wedlock, like Graves, regularly visits with students to discuss situational awareness, though his focus is on sixth-grade students.

“We do a character building

Denna, 5 and a half, and Eric Olason, 3, and Layla Formanack, 5, settled back into their child-sized wooden chairs during story time at 10:30 a.m. at the Mound City Public Library on Tuesday, Feb. 18. Librarian Carly Edwards adjusted her book, *The Pout-Pout Fish in the Big-Big Dark*.

“I’m a pout-pout fish,” Edwards read, “so I spread the dreary-wearies all over the place. Blub...blub...blub...”

The three children listened quietly, their legs swinging an inch or two above the carpeted floor.

“I’m a kiss-kiss fish with a kiss-kiss face for spreading cheery-cherries all over the place,” Edwards finished, her voice rising with each word.

Edwards reached for the next book, *Rainbow*

Fish to the Rescue by Marcus Pfister, to the children’s delight. The cover, colorful and sparkling, attracted the trio’s attention, and they eagerly gathered around Edwards.

“Ok let’s have a seat,” she instructed.

Edwards lifted the book to hold in one hand while she read and quizzed Denna, Eric and Layla on vocabulary. At the end of the story, she allowed her rapt audience to voice their opinions.

“Those pink fish are pretty,” Denna remarked.

“I like that one, that one, that one, that one, that one, that one, and that one. And that one. And that one,” Layla said.

“That’s about all of them,” Edwards responded.

“Yeah, I like all of them,” Layla smiled.

Mound City students take energy efficiency to the next level

Eryn Acton and Lily Grant, seniors at Mound City High School, had a seed of a project idea that swiftly bloomed into a prize-winning showpiece.

“[Eryn and Lily] took the topic ‘Energy Efficiency’ and created a brilliant video to show us the importance of green topics,” the students’ Future Business Leaders of America (FBLA) sponsor Nichole Hux wrote to *Mound City News*.

Acton and Grant, who competed in the district FBLA digital video contest at Northwest Missouri State University in Maryville, MO, on Wednesday, Feb. 19, were inspired by the latest video fad.



“There’s a trend on YouTube, ‘Draw My Life’ videos,” Grant explained. “You illustrate your life on a white board and narrate over it.”

At their estimate, the two spent three hours planning their four-minute Draw My Lifestyle video, which explains the various effective and ineffective ways to use energy, and Acton spent three to four hours on the artwork. Grant finished the project

with five hours of editing. All told, the girls accomplished their project within one weekend. The frantic pace — the submission deadline was pushed up by a week — turned out to be a blessing.

EEZ plans slow down, Element Power gears up for open house meetings

Progress on the development of the Enhanced Enterprise Zone (EEZ) has slowed, according to Holt County Commissioner Mark Sitherwood, but county residents should be assured that plans are moving forward.

“[The process is] ongoing,” Sitherwood said.

The Commission recently faced a bump in the road when it came to taxation associated with an EEZ. To break it down, the purpose of an EEZ is to create tax incentives for new businesses, one of which could potentially be Mill Creek Wind Farm, to be located in southeast Holt County. Holt County Assessor LaDonna Jones stated in the Holt County Commission meeting held on Thursday, Jan. 30, and to *Mound City News* that she had explored various taxation models for real estate associated with wind farms. She determined that the Gentry County model of taxation, which is “affirmed by the Missouri State Tax Commission,” set the current precedent in the Show-Me State. That model applies a 60 percent obsolescence at the start of the project.

“Obsolescence,” Jones explained, “is derived from the capacity factor the wind turbines [need] to function.”

To put it at its simplest, obsolescence is a tax break. Accounting for the 60 percent, the county would be left with 40 percent of the taxes associated with the construction value of the wind farm. Of that 40 percent, if the county were to approve an EEZ real estate abatement, which accounts for 50 percent of the remaining percentage for a period of 10 years, the county would retain 20 percent of the taxes related to the wind farm. That 20 percent

class," Wedlock said.

Wedlock added that many of the safety lessons he provides can stick with a student as he or she ages into adulthood.

"Later in life, they [remember] listening to [certain] parts."

To combat any potential danger, Wedlock, Graves, the Safe Side and a recent article in *The Kansas City Star* are advising students and parents to take heed of the following suggestions:

- Children should walk in groups, not alone;
- Children should not approach any vehicles that pull over nor should they talk to any drivers;
- If a child is approached he or she should scream and yell, run to the nearest house to bang on the door or run home;
- Should a person try to grab a child, the child should kick, scream, pull hair, wriggle around, scratch, and do whatever he or she can to get away;
- If a child has a cell phone, he or she should plan to stay connected with a parent throughout the day;
- When in a mall or a public place, children and parents should take notice of the well-lit areas and observe

whether the rest rooms look safe;

- Parents should discuss specific situations with children and what they should do. After the initial discussion, parents should bring it up again to reinforce any information.

Parents would also be wise to take advantage of the Missouri Child Identification Program (MoCHIP). With a parent's permission, children between the ages of 0 and 21 can participate in and receive the results of the five major components: digital photographs, digital fingerprints, child information and emergency contacts, dental bite impressions and two laminated ID cards. Should a child be abducted, the MoCHIP information can be immediately given to a law enforcement officer to help with identification. The program is free, and all personal information is wiped from computers.

"They break [MoCHIP] up into counties," Wedlock said. "They came to Mound City a couple of years ago."

Wedlock also noted that frequent and at-risk participants of the MoCHIP program are college students.

"I was amazed at the young adults that came," Wedlock said.

MoCHIP will next be in the area from 10 a.m. to 2 p.m. on Saturday, April 12, at Albany Fire

House #3 in Albany, MO.

Should the unthinkable happen, however, and a child or teenager be abducted, the best recourse is the AMBER Alert.

The America's Missing: Broadcast Emergency Response (AMBER) Alert first began in 1996 after Amber Hagerman was kidnapped while riding her bicycle in Texas; she was later found murdered, and her case remains open. In 2002 the AMBER Alert became open to all U.S. states; by 2009 it was also available in Puerto Rico, the U.S. Virgin Islands and several Native American tribes.

"[The AMBER Alert]," Wedlock clarified, "is an organized system nationally geared toward children in serious peril or in harm's way."

The key for an abduction to qualify for an AMBER Alert lies in the term "peril," Wedlock added. The next level below is "endangered persons," where a child might have been taken but is not necessarily in severe danger, in which case the Child Abduction Response Teams (CART) may respond.

"It's a case-by-case thing a lot of the time," Wedlock clarified.

The AMBER Alert system, according to the Department of Justice, requires several additional criteria:

- Law enforcement must confirm that there has been an abduction;

- There is enough information about the child, the abductor and the abductor's vehicle to issue an alert;
- The child must be under the age of 17;
- The information must be entered into the FBI's National Crime Information Center and flagged.

Once the criteria have been reached, law enforcement officers notify state transportation officials and the media. AMBER Alerts are also issued on wireless devices, lottery tickets and over the internet.

"The magic of the AMBER Alert is that you get a whole bunch of people looking," Wedlock said.

As of Friday, Jan. 3, the AMBER Alert has helped rescue and return 679 children, the Department of Justice reported. Most recently, on Friday, May 31, 2013, a boy in Missouri was returned to authorities after his abductor, a non-custodial parent, saw the AMBER Alert and contacted the police.

While the system isn't perfect ("The downfall is people don't listen to live radio," Wedlock pointed out), it is an effective safeguard when worse comes to worse. If parents and their children practice safe behavior, though, the AMBER Alert can remain a last, and powerful, resort.

The search for Missouri Century Farms in Holt County continues

If a farm has been in a family since Dec. 31, 1914, owners may now apply to have it recognized as a Missouri Century Farm.

To qualify, farms must meet the following guidelines:

- The same family must have owned the farm for 100 consecutive years.
- The line of ownership from the original settler or buyer may be through children, grandchildren, siblings and nephews or nieces, including through marriage or adoption.
- The farm must be at least 40 acres of the original land acquisition and make a financial contribution to the overall farm income.

"It is important to honor and respect our history," said Michael Ouart, vice provost and director of University of Missouri (MU) Extension. "These farms represent both Missouri's cultural heritage and the good stewardship that our farmers strive for."

To contribute to the cause, Missouri Farm Bureau joined MU Extension and the MU College of Agriculture, Food and Natural Resources in 2008 as a sponsor for Century Farms.

"Missouri Farm Bureau is a proud partner in the recognition of Century Farms," said Blake Hurst, president. "We applaud the hard-working farm families that have kept us fed and clothed for generations. They represent an important part of our heritage and laid a foundation for the bounty Americans enjoy every day."

Applicants certified as owners of a 2014 Missouri Century Farm will be recognized by the MU Extension center in the county where the farm is located. Applicants will be presented with a sign and a certificate.

Since Missouri began the program in 1976, more than 8,000 Century Farms have been recognized.

Mary Elizabeth (Betty) Schooler of Craig, MO, passed to a new life on Saturday, Feb. 22, 2014. For more than 97 years, she loved and laughed and rejoiced in her faith. Schooler was born on August 27, 1916, in Omaha, NE. She was the oldest of five children born to Earl and Georgia Dean, and she spent her early years in the Benson area of Omaha.



Schooler attended Park University in Parkville, MO, where she met her future husband, Wilber Schooler. They were married on Feb. 17, 1938, in Omaha and resided in Craig throughout their married life. The couple owned and operated Schooler's General Store and the Schooler Funeral Home. Schooler loved to shop and enjoyed being the buyer of ready to wear, notions, piece goods and assorted trinkets and novelties for the store. She dearly loved the Craig community and was proud of the care and services that she and her husband were able to provide to grieving families through their funeral services. It was a heart-wrenching job in the small community where a person knew and was friends with everyone. Following her husband's death in 1992, Schooler sold the store and the funeral business.

For the past 20 years, Schooler served as the operating manager of Schooler Family Farms. She looked forward to driving around the farm, observing the rise and fall of the Big Tarkio River, the planting and harvesting of corn and soybeans, and conferring and planning with the outstanding farmers who provided the day-to-day farming operations. Starting in 2007, Schooler resided at Brighton Gardens Assisted Living in Prairie Village, KS, to be close to her Kansas City family and to her farming interests.

Schooler served on the Fairfax Drainage District and the Holt County Democratic Committee. She was active in the Craig Presbyterian Church and served on the session. Most importantly, she was a wonderful mother and best friend, loving sister and caring aunt. Although many of her Craig friends have already made the journey, she cherished the new friendships with residents, caregivers and staff of Brighton Gardens. - Sponsored the local 4th of July celebration, total expense of the celebration, \$1,210.44 - total receipts from all sources, \$1,182.51

would not be enough revenue for the county, the Holt County Commission decided.

"It just didn't seem right," Jones said. "It wasn't in the county's best interest."

Although the establishment of an EEZ may not be perfect for the county right now, the Commission is moving forward with the required EEZ board, and Jones has stated in Commission meeting minutes that she will continue to explore the Gentry County model of taxation.

"We're still on board [with Element Power, who will build and operate the wind farm]," Sitherwood added. "We're in the process of negotiating and moving forward. We've got some numbers to look at."

For its part, Element Power will be holding two open house meetings at which attendees can learn more about wind farms and any ramifications of building and running one in Holt County. The first meeting will take place on Tuesday, March 4, at the T.J. Hall Community Building in Oregon, MO; the second is scheduled for Wednesday, March 5, at the Nutrition Site in Mound City, MO. Both meetings will last from 5 p.m. to 8 p.m.

Establishing an EEZ and building Mill Creek Wind Farm is no small undertaking, and Sitherwood, in particular, is welcoming the opportunity to let the process decelerate.

"We're slowing down, but we needed to," he said. "It was brought on [really] quick. Everybody needs to take a chance to breathe."

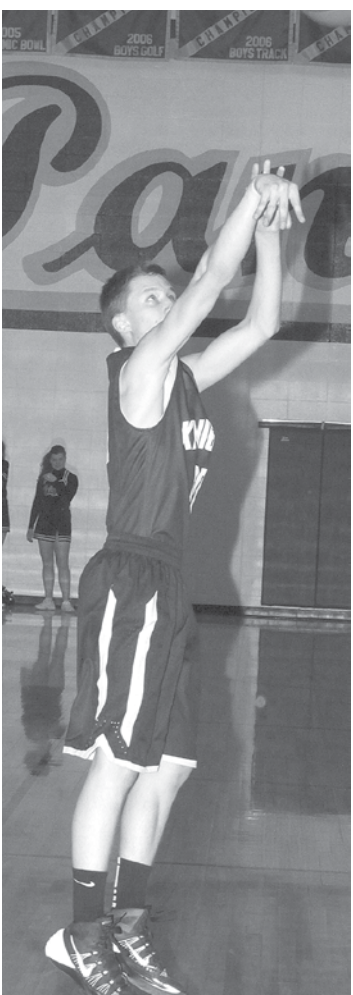

out, but then thought, 'no, we can't do that.'

"You and I both work best under pressure," Grant pointed out. "It work[ed] out best for us."

"We were really nervous starting," Acton said.

The girls had seven minutes to describe their video, Hux explained, and could only show two minutes of the final product.

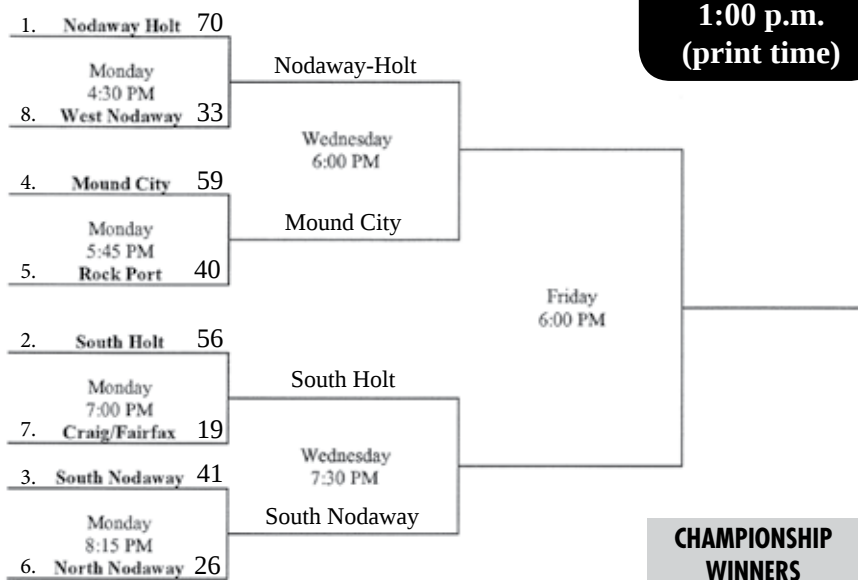

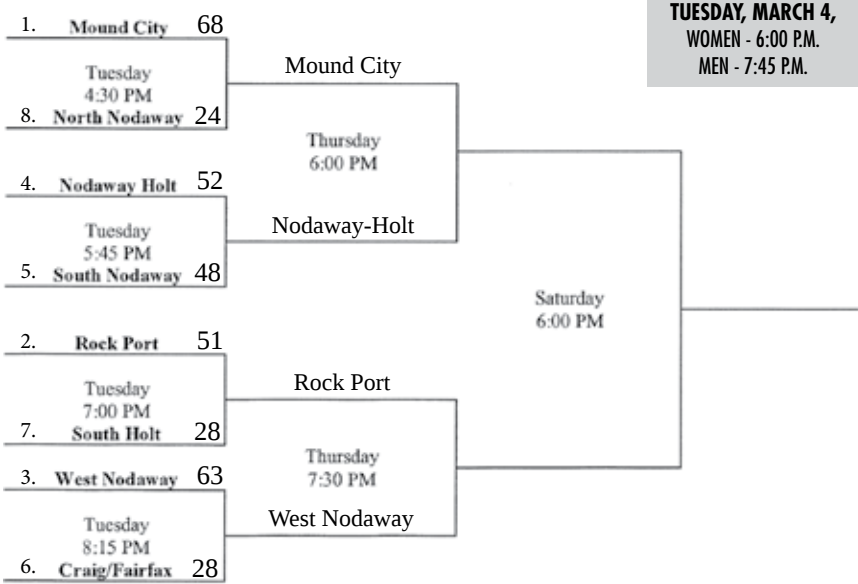

Statewide tornado drill scheduled for March 4

The National Weather Service, the State Emergency Management Agency (SEMA) and Missouri's local emergency management offices are urging Missourians to use Missouri Severe Weather Awareness Week, Monday, March 3, through Friday, March 7, to plan and prepare for how they will react to tornadoes, flash flooding and other severe weather. The Show-Me State will also conduct the 40th Annual Statewide Tornado Drill on Tuesday, March 4, at 1:30 p.m. If severe weather is in the forecast on March 4, the drill will be moved to Thursday, March 6, at 1:30 p.m.

"It's important to remember that tornadoes and dangerous flash flooding can develop rapidly and with little warning," Gov. Jay Nixon said. "I encourage Missourians to talk at home, at work and at school about severe weather safety so that in times of real emergency, folks are prepared for whatever Mother Nature brings." During the drill, Missouri outdoor warning sirens and weather alert radios will sound, indicating that Missourians should seek shelter. The safest location is the basement or an interior room in the lowest level of a building. The drill is complete once everyone is accounted for in the designated shelters.

Missouri's Stormaware.mo.gov website includes detailed videos showing how to react to severe weather and shelter in specific types of buildings — houses with and without basements, mobile homes, schools — and important information about tornado sirens and weather alert radios. The site also includes links to free severe weather texting services that can alert people across Missouri to upcoming severe weather.

The National Weather Service (NWS) provides safety tips and educational information about each day of Severe Weather Awareness Week on the St. Louis Forecast Of-

ice site: <http://www.crh.noaa.gov/lx/?n=severeweek> (Monday, Preparedness Day; Tuesday, Tornado Safety Day; Wednesday, Flash Flood Safety Day; Thursday, Severe Thunderstorm Day; Friday, NOAA Weather Radio Day).

- Remember:
- "Tornado watch" means watch the sky. A tornado may form during a thunderstorm.
 - "Tornado warning" means seek shelter immediately.
 - An interior room without windows on the lowest floor is the safest shelter location.
 - Do not seek shelter in a cafeteria, gymnasium or other large open room because the roof might collapse.
 - Immediately leave a mobile home to seek shelter in a nearby building.
 - Overpasses are not safe. An overpass' under-the-girder-type construction can cause a dangerous wind tunnel effect.
 - If a person is driving, he or she should stop and take shelter in a nearby building.
 - If a person is driving in a rural area, drive away from the tornado to the closest building. If it is impossible to get away, seek shelter in a roadside ditch. Cover heads with arms, a coat or a blanket to protect from flying debris. Be prepared to move quickly in case the ditch fills with water.
 - Never drive into standing water. It can take less than six inches of fast moving water to make a slow moving car float. Once floating, a vehicle can overturn and sink.

National Heart Month: February

"In the last few years, we have seen [a] greater prevalence of heart conditions in our community, and we saw the need for more heart health education," Martin said. "We were grateful for the opportunity to come to Holt County and appreciate those who participated in our screening."

Cover crop and soil health workshop

The Natural Resources Conservation Service (NRCS), the University of Missouri (MU) Extension and the Atchison and Holt County Soil and Water Conservation Districts will host a cover crop and soil health workshop from 9 a.m. to 4 p.m. on Thursday, March 6, at the Tarkio Community Building in Tarkio, MO. This year's speaker will be Dave Brandt, who farms more than 1,100 acres in Ohio with a corn-soybean-wheat rotation. According to Chris Rader of NRCS, Brandt has been no-tilling for 39 years and cover-cropping for 34 years. He has seen firsthand how using radish plants as cover crops can increase yields up to 20 percent and decrease diseases in both soybeans and wheat. By fixing nutrients with cover crop mixes, Brandt also found he could lower fertilizer costs. He has also had radish tubers analyzed, and tests showed that radishes recycle 250 pounds of nitrogen, 230 pounds of potassium and 23 pounds of phosphorus per acre.

Additional speakers at the workshop include NRCS staff members, who will discuss new soil health tests, methods for interpreting the results and cost-share potential. A rainfall simulation and soil erosion demonstration are also planned, and Wayne Flanary, regional agronomist with MU Extension, will present his findings on the cover crop trials at Graves Chapple Research Center.
