**A mechanical room (pictured above) at Craig (MO) R-3** - Was the source of a fire at the school, discovered on Wednesday morning, May 25. According to fire inspection findings, the fire is thought to have been in or around the water heater in the room. The fire is believed to have started around 9:30 p.m. the night before. Thick smoke and broken water lines caused most of the damage to the locker rooms, gymnasium and stage/band room areas. Superintendent Mike Leach reports the insurance-covered damage will take 90-120 days to repair.

## Fire strikes at Craig R-3 school; smoke and water damage takes its toll

Remnants of an intense fire were discovered Wednesday morning, May 25, at Craig R-3 in Craig, MO. School custodians entered the building at 7 a.m. and smelled smoke. Upon investigation, the crew opened the doors to the gymnasium and black smoke came billowing out. The doors were immediately shut and emergency personnel were notified.

The Northwest Holt Fire Protection District in Craig was on the scene in minutes, discovering the worst fire damage in a mechanical room at the northwest corner of the building. The room contained an electrical box, water heater and other miscellaneous items. According to preliminary reports, the fire started in or around the water heater and is believed to have started at approximately 9:30 p.m., when the power, phone services and internet services were lost.

With no windows in the mechanical room, the fire went unnoticed until custodial personnel entered the school at 7 a.m. Wednesday. Apparently, the intense heat of the fire melted the solder on the water pipes in the room, causing the pipes to separate and send water into the room, dousing most of the fire. Smoldering continued throughout the night, causing extensive smoke and soot damage throughout the gymnasium and surrounding area. The exposed water pipes also produced a pool of water on the north half of the gymnasium floor and in

the locker rooms.

The school's insurance company, Missouri United School Insurance Council (MUSIC), was immediately notified and had Catastrophe Cleaning and Restoration Co., Inc. (CATCO), on the scene by 11 a.m., Wednesday. The crew removed the water from the gym floor and began sweeping the soot off the south end of the gym floor. The school had refinished the gym floor the week before the fire and CATCO stated the fresh sealant would possibly help to save the floor. It is not known at this time if any of the floor has been damaged.

Adam Crouch with the Missouri State Fire Marshal's Office spent Wednesday at the school to determine the cause of the fire. No report had been received as of press time.

On Thursday, MUSIC's fire, electrical and claims' inspectors were at the school. "They ruled the fire no-fault accidental and gave approval for full insurance coverage of the incident. The next two weeks, we will concentrate on cleanup and evaluating the situation," stated Superintendent Mike Leach on Thursday, May 26. "We are anticipating 90-120 days of repairs, which will put us into the fall and the start of school." Mr. Leach is expecting a smooth opening of the 2016-2017 term, with most of the repairs having been made at that time.

From the *Mound City News* archives

### 50 Years Ago - 1966

- The 68th annual alumni banquet was held at Mound City High School with 388 persons attending. J.C. Strobel, president of the Alumni Association, conducted the business session. Mrs. Harold Robinson was in charge of the program; Harold Thompson was master of ceremonies. Music for the dance, which followed, was provided by the Avon Coffman Orchestra of Oregon.

- Mrs. Alva (Trena) Bomar was advertising the opening of her fee fishing lake. The new fishing haven was located south of Mound City.

- The New Point alumni banquet was held at the school building in New Point with 112 guests present. The Woodville Quartet, accompanied by Mrs. Irwin Sommer, furnished the music.

- The Oregon Garden Club presented its 19th annual flower show at the Oregon Methodist Church. The theme of the show was "A Floral Beauty Journey." There were 47 horticultural classes and 17 classes in artistic design.

### 25 Years Ago - 1991

- One new business opened on Mound City's main street late last week and another was expected to be open soon. Don Carter of Barnard opened the Red Rock Saloon. Across the street, booths and kitchen equipment had been installed and workers at Bredeaux Pizza said it would soon be open.

- Just over 3,000 acres of Nodaway River bottomland, most of it in Holt County, was being bought by the state for a new wildlife area near New Point. The New Point site would be the third major wildlife area in Holt County.

- More than 300 people attended the annual Mound City alumni banquet. Alumni from Mound City, Bellevue and Bigelow schools gathered for the fun.

- Work had started behind The Klub on a new sand volleyball court. Seven teams had signed up for a summer league.

- The Holt County Historical Society Schoolhouse Museum was again the scene of the annual Fortescue School reunion and banquet. About 90 people were present for the evening.

### 10 Years Ago - 2006

- Craig was getting a new water tower and construction was expected to start within the month.

- About 200 people attended the annual Mound City Alumni Banquet.

- Alex Callow, who would be a junior at Nodaway-Holt, was selected to attend the Missouri Scholars' Academy in June at the University of Missouri-Columbia.

- Biscuits and gravy and garage sale goodies were offered by the Holt County Historical Society at the Mound City Nutrition Site during the city-wide garage sale on Memorial Day.

### WALKER COUNTRY SCHOOL 1936

Walker School was located in the "Arkansaw" neighborhood west of Big Lake on the George Walker (Gracie Chuning Boyd's grandfather) farm. The Walkers donated a corner of land for the school. Fred Chuning, Independence, MO, donated the photo to the Holt County Historical Society.

The first school in "Arkansaw" was the White/Mann Country School located near the Missouri River on the Charley Mann Farm. It was sometimes referred to as the Mann or White school. Joe Catron and Steve, Bill, and Alice Cunningham were among those who attended there. Joe Catron was just a young child and was afraid to walk alone from his home to attend classes. Mrs. Minnie Lundy Goolsby stayed with the Catron family and walked to school with Joe. Later on, Mrs. Linda Chuning stayed with the Catrons and accompanied Joe until he was old enough to go alone. The Missouri River cut in the school and it was necessary to move it over to the Walker farm. O.P Light from the Kelso neighborhood was an early teacher. Joe Catron returned at the age of 19 and took 9th grade under him. Mr. Light returned later to teach there and taught Joe's daughter, May Catron Dodson, in 1904-05. About 1904, it was a very large school. Children brought their own boxes to sit on.

Families who attended Walker included the George Chunings; the Catrons; Bob Mullins; the four Coonce children; Paul, Ralph, and Gerald Graham; Bryant family; Alexanders; Goolsbys; Bridgemans; Grace and Harry Coatney; Jim Rowland; Jim Smith; the Kissell family; Frank Chaney's girls; the Poynters; and Ada and Pearl Jackson.

Teachers included Willie VanVickle 1905-06; Tom Zachary 1906-07; Albert McKown 1907-08; Bessie Stanley Laukemper 1908-09; Albert McKown returned 1909-1912; Josephine Wilson 1912-13; and Allen G. Stanley 1913-14. During the time that Stanley taught, the Literary Society was formed. Frank, Albert, and Henry Dougherty, from the Glendale School area, were champion debaters. Later teachers were: Mrs. Julia Minton, Bessie Laukemper, Gladys Varvel, Lois Smith Goolsby, Mrs. Ulmer, Mrs. Stigal, Mrs. Lowry, Hillene Baker, Clara Belle Hill Wiley, and Lila Dodge Williams. In 1938-39, Walker closed and moved into Fortescue School at Christmastime.

A complete history of White/Mann/Walker School, along with photos, is in the center files. The information is recollections of Mae Catron Dodson, Gladys Lease Varvel, Jennie Lundy Kent, Marie Lundy Stone, Josephine Coatney Morris, Ada Jackson Chuning, Constance Gaskill Siekmann and Bryan and Lois Smith Goolsby.

## Hazard Mitigation Plan looking for municipal partners; search on for pictures for 175th celebration

The Holt County Commission met Monday, May 16, 2016, at 9:00 a.m., in the Holt County Courthouse at Oregon, MO. Presiding Commissioner Mark Sitherwood, First District Commissioner Bill Gordon and Second District Commissioner David Carroll were in attendance.

County Clerk Kathy J. Holstine presented minutes for approval. Following review, a motion was made, seconded and passed to accept the minutes as written.

Don Scheib, Oregon, appeared before the commission to request pictures for a 175th Anniversary display to be presented at the Holt County Autumn Festival, September 7-10. He is seeking pictures from throughout the county. Anyone interested in participating should contact Mr. Scheib directly.

Road and Bridge Supervisor Daryl Biermann joined the commission to give an update on Federal Emergency Management Agency (FEMA) project work, noting there are only a couple of projects remaining, including the repair of a damaged concrete box culvert on Holt Road 130. The county is waiting on FEMA improved project approval before proceeding to bid on this project.

In other matters, Mr. Biermann reported the Road and Bridge staff has removed a heavy metal door at the Mound City Mausoleum to ensure safety of anyone visiting the mausoleum over Memorial Day weekend.

Mr. Biermann and Commissioner Carroll reported that they met with landowner, Jerry Brown, and Missouri Department of Transportation (MoDOT) officials to review a cooperative project with Atchison County on Holt Road 100. Project plans call for an eight foot corrugated metal pipe, 70 feet in length with a 30-inch corrugated metal pipe at a field turn on the south corner of the project. MoDOT has agreed to place a new pipe at the junction of Holt 100 and Highway DD

to allow for a 60 foot turning radius at the access. Mr. Biermann also reported on the need to complete credit match projects for the federal BRO (bridge replacement offsystems) program. He lists three areas where 12-foot corrugated metal pipes are likely to be needed. Commissioners discussed having engineer Phil Schrick apply for Bridge Engineering Assistance Program (BEAP) studies on these bridges to determine feasibility.

Beth Castillo with Holt County Public Water Supply District #1 appeared before the commission to request right-of-way (ROW) allowance for Holt Road 250 to place a waterline from Maywood to a home structure along Holt 250. Commissioners reviewed the proposal with Commissioner Gordon making a motion to approve the use of ROW. The motion was seconded and passed.

Commissioners took up review of financial reports for the month ending April 30, 2016, including County Aid Road Trust (CART) rock funding and cash balances of the various accounts of the county.

Being no further business, the commission adjourned until Monday, May 23, 2016.

The Holt County Commission met Monday, May 23, 2016, at 9:00 a.m., at the Holt County Courthouse. Presiding Commissioner Mark Sitherwood, First District Commissioner Bill Gordon and Second District Commissioner David Carroll were in attendance.

Chance Long, Northwest Regional Council of Governments, joined the commission to discuss planning partners for the Hazard Mitigation Plan renewal. Mark Sitherwood, serving as Emergency Management Director, suggested contacting the mayors of each town in an effort to find persons to serve on the planning committee. The program re-

quires participation of at least one person from each organized city or village. Ms. Long is planning a lunch meeting in June to kick off the project. Anyone interested in participating should contact Emergency Management Director Mark Sitherwood.

Commissioners took up a request from Holt County Relay for Life to keep the courthouse open from 5:00 p.m. to midnight on Saturday, June 4, 2016. Commissioners approved the request and requested that Building and Grounds Supervisor Mike Brock be on hand to maintain the building during the event.

Brenda Nelson, R.N., Health Department Administrator, requested approval to purchase two storage carts and insect repellent. Commissioners approved her request. She will pursue state funding for the insect repellent. Mrs. Nelson also expressed concern for bird droppings at the Health Department and requested assistance to remove the nuisance birds.

Sheriff Scott Wedlock joined the commission to present a Certificate of Origin for two patrol vehicles from Laukemper Motors, Mound City.

Road and Bridge Supervisor Daryl Biermann gives an update on various Road and Bridge Department projects. Commissioners took up an interview with Drew Ireland for a position with the Road and Bridge Department at the Mound City Barn. Commissioners offer the position at \$11.00 per hour pending passage of a Department of Transportation (DOT) physical and drug test.

Commissioner Carroll reported on work completed in the previous week by the Road and Bridge Department, including fixing a washout on Omaha Road north of Holt Road 180 and application of CART rock.

# MDC sets upcoming migratory game bird and waterfowl seasons

*Seasons include more days for dove hunting, 60 days for ducks and changes for geese*

At its Friday, April 29, meeting, the Missouri Conservation Commission approved recommendations on hunting seasons and limits from the Missouri Department of Conservation (MDC) for the upcoming 2016 migratory game bird season and 2016-2017 waterfowl season. The approved recommendations include 20 additional days for dove hunting, a 60-day season for ducks, and changes to season timing and length for geese.

"The federal frameworks for Canada geese and white-fronted geese recently changed," explained MDC Resources Scientist Andy Raedeke. "As a result, the department was able to eliminate separate season dates for different species of geese and offer a single goose season that begins on Veterans' Day (Friday, November 11, 2016) and closes on Monday, February 6, 2017. These changes will provide hunters with the latest seasons in modern history for Canada geese and white-fronted geese in Missouri."

The commission also approved recommendations by MDC for the 2017-2020 duck-season-date formulas and changes to zone boundaries.

Season: Sept. 1 through Nov. 29 (includes 20 more days)

If the youth hunter is not certified in hunter education, the adult must have the required permits and have in his or her possession proof of hunter-education unless exempt. The adult may not hunt ducks but may participate in other seasons that are open on the special youth days.

Falconry Season for Doves

Season: Sept. 1 through Dec. 16  
Limits: 3 daily and 9 in possession, singly, or in the aggregate (any waterfowl taken by falconers must be included in these limits)  
Hours: One-half hour before sunrise to sunset

Falconry Season for Ducks, Coots, and Mergansers

Season: Feb. 10 through March 10  
Limits: 3 daily and 9 in possession, singly, or in the aggregate during the regular duck-hunting seasons (including teal and youth seasons) and extended falconry seasons (any doves taken by falconers must be included in these limits)  
Hours: One-half hour before sunrise to sunset

Light Goose Conservation Order

Season: Feb. 7, 2017, through April 30, 2017 (new opening date)  
Limits: No daily or possession limits  
Hours: One-half hour before sunrise to one-half hour after sunset

Requirements: Persons must possess a Conservation Order permit to participate in the Conservation Order. An exception to the above permit requirement includes any person 15 years of age or younger provided either she or he is in the immediate presence of a properly permitted adult hunter 18 years of age or older with hunter-education certification or who is exempt.

Methods: For the taking of blue, snow and Ross's geese, hunters may use shotguns capable of holding more than three shells and recorded or electronically amplified bird calls or sounds or imitations of bird calls or sounds.

## CURRENT ZONE DESCRIPTIONS

**NORTH ZONE:** That portion of Missouri north of a line running west from the Illinois border at Lock and Dam 25; west on Lincoln County Hwy. N to Mo. Hwy. 79; south on Mo. Hwy. 79 to Mo. Hwy. 47; west on Mo. Hwy. 47 to I-70; west on I-70 to the Kansas border.

**SOUTH ZONE:** That portion of Missouri south of a line running west from the Illinois border on Mo. Hwy. 74 to Mo. Hwy. 25; south on Mo. Hwy. 25 to U.S. Hwy. 62; west on U.S. Hwy. 62 to Mo. Hwy. 53; north on Mo. Hwy. 53 to Mo. Hwy. 51; north on Mo. Hwy. 51 to U.S. Hwy. 60; west on U.S. Hwy. 60 to Mo. Hwy. 21; north on Mo. Hwy. 21 to Mo. Hwy. 72; west on Mo. Hwy. 72 to Mo. ## NONTOXIC SHOT REQUIREMENTS

Shells possessed or used while hunting waterfowl and coots statewide, and for other species as designated by posting on public areas, must be loaded with material approved as nontoxic by the U.S. Fish and Wildlife Service.

## LOOKING AHEAD TO 2017-2020

The Conservation Commission also approved MDC recommendations for the 2017-2020 duck-season-date formulas and zone boundaries.

"The U.S. Fish and Wildlife Service gives states the opportunity to change the number and location of duck zones about every five years and we consider adjustments to season dates at the same time," explained MDC Resources Scientist Andy Raedeke. "States can also select a continuous season or split season, which refers to a season that is open for a period of time, closes, and then reopens for a second period of time. Once selections are made, Missouri then keeps the same season-date formulas and zone boundaries for multiple years, with the next ones being for 2017 to 2020."

### 2017-2020 North Zone Formula

- 60 Days: A continuous season that opens on the first Saturday in November
- 45 Days: A continuous season that opens on the second Saturday in November
- 30 Days: A continuous season that opens the Saturday nearest Nov. 14

### 2017-2020 Middle Zone Formula

- 60 Days: A split season that opens the Saturday nearest Nov. 6 for seven days, closes for five days, and then reopens for the remaining 53 days
- 45 Days: A continuous season that opens on the Saturday nearest Nov. 15
- 30 Days: A continuous season that opens on the Saturday nearest Nov. 19

### 2017-2020 South Zone Formula

- 60 Days: A split season that opens on Thanksgiving Day for four days and then closes the number of days necessary to enable the remaining days to extend through the last Sunday in January
- 45 Days: A split season that opens the Saturday nearest Dec. 10, closes Dec. 20-25, and then reopens from Dec. 26 through the last Sunday in January
- 30 Days: A split season that opens the Saturday nearest Dec. 15, closes Dec. 19-25, and then reopens from Dec. 26 through the Sunday nearest Jan. 20

### 2017-2020 Zone Boundary Adjustments

The North/Middle Zone boundary in west Missouri will be adjusted to include Smithville Reservoir, the Missouri River, Dalton Cutoff, and a greater proportion of the Missouri River floodplain in the Middle Zone.

The South/Middle Zone boundary in west Missouri will be moved to Hwy 54 to put Barton, Jasper, and portions of Vernon counties back into the South Zone.

### Hunter Input

Raedeke noted that recommended changes depend primarily upon hunter input and a wide variety of hunter preferences.

"Our goal is to establish zone boundaries and season dates based on hunter input and that best accommodate various types of waterfowl hunters and their preferences," explained Raedeke. "That includes hunters with varying levels of experience and those who hunt in different types of habitat, those who target different species, hunters who have varying physical capabilities and hunters who use different hunting styles."

Hunter input included responses from 3,515 individuals who completed MDC's 2014 Duck Hunter Opinion Survey, comments from 538 hunters who attended one of the department's 14 recent waterfowl-hunter workshops, and other comments received from waterfowl hunters. He added that given the range of hunter preferences, not all hunters will be completely satisfied with season dates and zone boundaries.

"Our aim is to accommodate at least a portion of most hunters' desires," said Raedeke. "We listen to what waterfowl hunters want and sincerely appreciate their time, effort, and input."

## Missouri Department of Health and Senior Services recommends ways to protect against bug bites

With summer right around the corner, the Missouri Department of Health and Senior Services (DHSS) compiled the top five tips for protecting

against mosquito and tick bites. Missourians all across the state will be enjoying great parks, trails and streams, and should know all the proper precautions to take.

Additionally, while there have not been any cases of Zika virus locally transmitted in Missouri or anywhere else in the continental United States, these tips can help people protect themselves from all mosquito and tick-borne illnesses and ease concerns Missourians may have.

"We want Missourians to enjoy all the great parks, trails and streams our state has to offer, while also protecting themselves from mosquito and tick bites," said Missouri Department of Health and Senior Services Acting Director Peter Lyskowski. "A few easy steps, like wearing insect repellent or ensuring there is no standing water around a person's home, provide protection against very serious diseases that bugs can carry."

DHSS lists these top five tips as the best way to protect against bug bites:

1) Wear insect repellent on skin and clothing: When used correctly, insect repellent is the best way to avoid mosquito and tick bites, and even children and pregnant women can use it. Consult the CDC for acceptable repellent: <http://www.cdc.gov/westnile/faq/repellent.html>.

2) Wear loose fitting clothing that covers skin: When weather permits, wearing long, loose-fitting shirts and pants can reduce chances of getting bitten by a mosquito, especially when combined with the use of insect repellent.

3) Ensure windows, screens are secure and use air conditioning when possible: Keeping the doors, screens and windows in the home secure and intact, along with using air conditioning to keep the house cool when possible, will help reduce exposure to mosquitoes by keeping them outside.

4) Eliminate standing water around the home: Mosquitoes can lay eggs in water-filled containers. Once a week, empty and scrub, turn over, cover or throw out items that hold water, such as tires, buckets, planters, toys, pools, birdbaths, flowerpots or

trash containers. Check inside and outside the home.

5) Talk to family members and friends about the importance of mosquito bite avoidance: The best way to help protect loved ones is by sharing these tips and suggestions with friends or fam-

ily members.
